# Finger Lakes Vineyard Update

#### Winter Bud Injury by Location

As I mentioned in my email last week with the results of our bud injury survey, we organized the data from our collection both by variety and by location. Included below are the results based on location, organized by each lake where we collected samples.

As you can see from the data, and as we've been saying and hearing from growers all along, the damage varies a lot between locations. The 'banana belt' of southeast Seneca Lake seems to have fared the best overall, at least in the areas where we surveyed, with the worst damage mostly showing up in the northern portion of the Finger Lakes.

In addition to this work, we will be conducting another assessment in vineyards this summer looking at the level of trunk injury in these same blocks where we collected bud injury samples. Our goal is to come up with an overall assessment of vineyard damage from this winter and estimate the economic impact of that damage, similar to the survey that Tim Martinson and Bill Wilsey conducted in 2004. We have also been in contact with the Department of Ag & Markets to discuss how we might demonstrate (if we can) that there is enough damage in certain varieties (e.g., Riesling) to allow farm wineries to purchase fruit from outside of New York. The legal threshold where this exemption would be triggered is a 40% reduction in yield *across the state* for any particular variety. My guess is that most wineries would not use this provision, but there might be some who would want or need to this year. We are hoping to have this determination made very soon.

# USDA Officially Announces Sign-Up Date For Farmers and Rancher Disaster Assistance Programs

Sign-Up Begins April 15th for Livestock, Honeybee, Fruit Grower Programs

WASHINGTON, April 7, 2014 – The U.S. Department of Agriculture (USDA) announced today that farmers and ranchers can sign-up for disaster assistance programs, reestablished and strengthened by the 2014 Farm Bill, beginning Tuesday, April 15, 2014. Quick implementation of the programs has been a top priority for USDA.

"These programs will provide long-awaited disaster relief for many livestock producers who have endured significant financial hardship from weather-related disasters while the programs were expired and awaiting Congressional action," said Agriculture Secretary Tom Vilsack. "President Obama and I prioritized the implementation of these disaster assistance programs now that the Farm Bill has restored and strengthened them."

The Livestock Indemnity Program (LIP) and the Livestock Forage Disaster Program (LFP) will provide payments to eligible producers for livestock deaths and grazing losses that have occurred since the expiration of the livestock disaster assistance programs in 2011, and including calendar years 2012, 2013, and 2014.

Enrollment also begins on April 15 for producers with losses covered by the Emergency Assistance for Livestock, Honeybees, and Farm-Raised Fish Program (ELAP) and the Tree Assistance Program (TAP).

LIP provides compensation to eligible livestock producers that have suffered livestock death losses in excess of normal mortality due to adverse weather. Eligible livestock includes beef cattle, dairy cattle, bison, poultry, sheep, swine, horses, and other livestock as determined by the Secretary.

- **LFP** provides compensation to eligible livestock producers that have suffered grazing losses due to drought or fire on publicly managed land. An eligible livestock producer must own, cash lease, or be a contract grower of eligible livestock during the 60 calendar days before the beginning date of the qualifying drought or fire in a county that is rated by the U.S. Drought Monitor as D2, D3, or D4.
- **ELAP** provides emergency assistance to eligible producers of livestock, honeybees and farm-raised fish that have losses due to disease, adverse weather, or other conditions, such as blizzards and wildfires, as determined by the Secretary of Agriculture.
- TAP provides financial assistance to qualifying orchardists and nursery tree growers to replant or rehabilitate eligible trees, bushes and vines damaged by natural disasters.

USDA Farm Service Agency (FSA) employees have worked exceptionally hard over the past two months to ensure eligible farmers and ranchers would be able to enroll to receive disaster relief on April 15.

To expedite applications, all producers who experienced losses are encouraged to collect records documenting these losses in preparation for the enrollment in these disaster assistance programs. Information on the types of records necessary can be provided by local FSA county offices. Producers also are encouraged to contact their county office ahead of time to schedule an appointment.

Note – A fact sheet with details about the Tree Assistance Program (TAP) that was authorized in the recent Farm Bill follows this article. We will have more information soon about other FSA programs that growers may want to consider applying for in the wake of this year's winter injury.

Tree Assistance Program for Orchardists and Nursery Tree Growers (TAP)

#### **OVERVIEW**

The USDA Tree Assistance Program (TAP) provides financial assistance to qualifying orchardists and nursery tree growers to replant or rehabilitate eligible trees, bushes and vines damaged by natural disasters occurring on or after Oct. 1, 2011. TAP was authorized by the Agricultural Act of 2014 as a permanent disaster program.

#### **ELIGIBLE TREE TYPES**

Eligible trees, bushes and vines are those from which an annual crop is produced for commercial purposes. Nursery trees include ornamental, fruit, nut and Christmas trees produced for commercial sale. Trees used for pulp or timber are ineligible.

#### **ELIGIBLE PRODUCERS**

To qualify for TAP, orchardists and nursery tree growers must:

- Have suffered qualifying tree, bush or vine losses in excess of 15 percent (adjusted for normal mortality) from an eligible natural disaster for the individual stand;
- Have owned the eligible trees, bushes and vines when the natural disaster occurred, but eligible growers are not required to own the land on which eligible trees, bushes and vines are planted;

• Replace eligible trees, bushes and vines within 12 months from the date the application is approved.

#### PAYMENT CALCULATION

For tree, bush or vine replacement, replanting, and/ or rehabilitation, the payment calculation is the lesser of the following:

- 65 percent of the actual cost of replanting, in excess of 15 percent mortality (adjusted for normal mortality), and/or 50 percent of the actual cost of rehabilitation, in excess of 15 percent damage or mortality (adjusted for normal tree damage and mortality) or;
- The maximum eligible amount established for the practice by the USDA Farm Service Agency's (FSA) Deputy Administrator for Farm Programs.

The cumulative total quantity of acres planted to trees, bushes or vines for which a producer can receive TAP payments cannot exceed 500 acres annually.
