Budbreak 2014

The warm and sunny weather over the past several days has finally given most vineyards the final push of energy to reach budbreak. It seems just about everything except for very late varieties like Vidal popped out over a couple of days. Most varieties, whether native, hybrid or vinifera, were all somewhere in the range of anywhere from budswell to having one or two leaves pulling away from the new shoot. Looking back on previous years' reports of budbreak, it looks like were somewhere in the range of about 7-10 days behind average budbreak dates.

The number of buds that are growing at this point was encouraging to see given the results of our winter injury survey that we did in March. We visited several vineyards yesterday before our Tailgate Meeting, including a couple where we had found very high levels of bud injury. While there still were a lot of dead buds, there were more pushing than we expected to see given our survey results. At least some are likely to be secondary buds that will have little or no fruit on them in most cases, but any little bit of potential good news certainly feels encouraging. We obviously still have to wait and see how many vines will end up succumbing to trunk injury, but for now, things looked a little bit better in some of these spots than we initially thought.

IPM - Climbing Cutworm and Grape Flea Beetle

Evidence of any activity by <u>grape flea beetle</u> has been hard to find so far. As shoots develop and move past budbreak, the insects may continue to feed to an extent but damage is not as significant as it is during budswell. In 2012, steely beetles caused significant damage in several vineyards around the area, mostly on

Concord. Fortunately, they did not return in nearly the same numbers in 2013, but the lesson is that higher populations can emerge in some years unexpectedly, so a little bit of scouting early on in the season can be beneficial.

Some varieties are rapidly moving through the budswell stage, and therefore likely won't be impacted significantly by any feeding that might happen at this point. Others may still linger in that stage for a little while, especially once the cooler weather arrives this weekend, so growers should still keep an eye open for them in any slower developing blocks.

In most years and in most vineyards, damage is not significant enough to warrant a spray for these pests. If scouting indicates the need for a spray application, however, materials and rates for both pests can be found on page 54 of the 2014 Grape IPM Guidelines.

Tailgate Meeting Wrap Up May 13, 2014

The first tailgate meeting of the year was last night and the weather was perfect. We had a great meeting at Fox Run Vineyards and would like to thank John Kaiser and the rest of the staff for hosting the meeting. We discussed the usual early season topics of steely beetle, weed control, and shoot thinning. We also talked about issues and strategies associated with this winters damage. There was lots of great discussion at the meeting and it was nice to see everyone.

During last nights meeting many growers echoed what we were seeing, that was that damage in blocks is widespread and variable. Varieties you expect to see significant damage in had little while other hardier varieties might not have faired so well. Some growers mentioned that while pruning earlier in the winter they noticed canes that didn't look healthy then. All of the talk about winter damage led us to talk about crop insurance, and the TAP program. Most growers who made a crop insurance claim have heard from an adjuster explaining that they will start evaluating vineyards in June. The big unknown is still trunk damage. We are seeing some vineyards with significant trunk injury. If you have any trunk injury it would be a good idea to document it and let the adjuster know.

Spring is a great time to attack perennial and early season annuals weeds. Since most varieties have started to break bud this week the use of glyphosate mixed in with preemergent herbicides should stop. In vineyards with significant bud loss the shoots that do develop have the potential to be very vigorous. One tactic to help decrease vine vigor could be narrowing the weed free band under the vines. Alan Lakso has shown there is a direct correlation between the width of the weed free strip under the trellis and vine size. If you decrease the size of the weed free strip under the vines it could help to reduce the vigor this year.

We would again like to thank John Kaiser and all of the staff at Fox Run Vineyards for hosting last nights meeting. Next Thursday May 22nd is our Spring IPM meeting at Standing Stone Vineyards. The next tailgate meeting is May 27th at Simmons Vineyards.
