LERGP Viticulture Extension Specialist Position Update

As most of you know the Lake Erie Regional Grape Program is currently working to fill the position of Viticulture Extension Specialist, left vacant when Luke Haggerty accepted a position with Constellation. While we wish Luke well in his new position we are aware that the viticulture position is a critical component in the success of the LERGP extension team so we are trying to move quickly to get a qualified person in as soon as possible.

We have a number of qualified applicants and will be looking at bringing them in for in person interviews early in the week of April 17 -21. The interview process will include presentations that are open to members of the grape industry and we encourage your participation. Those of you who attend the presentation will be provided a way to provide input to the search committee on how you feel the candidate would "fit" with the Lake Erie grape industry.

Potash News

Historically, potash prices remain low. It was back in early 2014 we saw FOB prices fall from \$365 to \$250 fairly quickly. Supply has continued to outstrip demand for the last three years as prices have continued to fall to \$195 per ton. Retail prices of potash are averaging \$320 in the US, right around fair market value relative to \$195.

Gensource Potash Corporation made news this week with efforts to mine additional potash in Saskatchewan. This would put this 65-million-dollar company in direct competition with PotashCorp. To compete with the 15-billion-dollar behemoth, Gensource plans to cut out the middle-man. It has raised capital with plans to construct a fairly significant mine (250,000 tonnes per annum). To justify the 200-million-dollar investment, it plans on selling potash directly to farmers and farmer-groups.

This investment is interesting on two levels. It is fascinating to see the possibility of further mine development given the depressed market prices for Potash. Mining companies have seen net revenue decline by more than 75%. PotashCorp has seen its stock price decline by over 60%. Most analysts were predicting investment in mining to stall out entirely, until prices were above \$350 per ton or more.

While Gensource is really taking a risk with this investment, it does underline a possibility that a sustained period of lower prices will really change market dynamics for potash. It appears that it is possible that inexpensive capital (low interest rates) will allow for continued investment and keep long-term Potash prices lower as the market finds new efficiencies to enhance revenue at lower prices.

It is likely that we will not see anything dramatic happen for a few years. Development on this scale does take time. Market disruption takes even more time. From a long-term perspective, as a grape grower, this will be interesting to watch.





Whether you have already, or have yet to visit our new website, lergp.com, we continue to add more resources for you. Our most recent addition to the website is the current Concord phenology (stage of growth) at CLEREL. On the left of the screen you will be able to find a photo and description of the current phenology. Right now of course, it is dormant bud. It also lists the Growing Degree Days (GDD) from January 1st, as well as from April 1st. Coming soon to this area of the site will be a Modified Shaulis field chart for you to assess the phenology on your farm. We encourage you to keep track of your phenology, and develop your own database of information, due to the fact that the dates for budbreak, bloom, and veraison vary across the grape belt.

Lergp.com is a work in progress. A visit to the site gives you access to all of our podcasts, which are posted every Wednesday, research information relative to growing grapes and hops, IPM, Business management, and an ever-expanding photo resource to help you identify pests and disease, and more.

We hope that this website will be a useful tool in your vineyard practices toolbox. DEADLINE for registration to take the test is **April 17**, **2017**. To register, call the DEC at (716) 851-7220. You will then be sent an exam application form and test instructions by the DEC.

Any questions about your eligibility to take an exam or the status of your current certification should be directed to the Buffalo DEC office at (716) 851-7220.

Commercial Applicators: You will need the "Core Manual" and the category manual for the area(s) in which you will be certifying.

Private Applicators: You will need to get the "Core Manual" plus the private category manual for the area in which you will be certifying.
