# FLGP Enrollment Reminder

At the end of this week, we will be creating our 2018 enrollment mailing list, which means this will be the final Vineyard Update that you will receive if you have not sent in your enrollment for the new season. The enrollment fee for 2018 remains the same as last year - \$75 for growers within the FLGP member counties, and \$130 for those outside of our region.



#### **Bud Hardiness**

My apologies to everyone for not keeping you updated on the results from our bud hardiness monitoring this winter.

The good news is that the temperatures recorded at each of our Finger Lakes sampling locations have not gotten very close to the LT50 readings recorded for the varieties that we have been monitoring. Based on the results through our March 5 sampling run (and March 12 at Geneva), the deacclimation process has been underway to various degrees for a few weeks now, as the temperatures have been generally trending up since about mid-January.



Low temperatures in the Finger Lakes the past few nights are lower than what we've seen for several weeks, reaching the low to mid-teens Sunday through Tuesday nights. Fortunately, the vines have not deacclimated to the point where those temperatures should be causing too many problems.

Yesterday, we collected what will probably be our final set of samples for this project. In a couple of weeks, we will collect buds from a subset of our sampling locations and assess bud injury. When we have those numbers, we will report those out to everyone as well. If you haven't already done so, I suggest checking buds at least on more winter-tender varieties to assess bud injury, which can give you an early idea of what you might expect for yields this year. 

#### There's Still Time to Respond to the 2017 Census of Agriculture

*I know that growers are asked to respond to a lot of surveys, but this an important one. A lot of USDA policies and programs are based on the information gathered for the Ag Census, so if you haven't done so already, please take some time in the next few days to provide information about your farm business before the season gets underway. - Hans* 

USDA's National Agricultural Statistics Service (NASS) needs a Census of Agriculture response from ALL the nation's producers. In order to get an accurate representation of American agriculture – of all farmers and ranchers across the country – NASS will continue to accept completed census questionnaires through spring. NASS has heard that some producers need extra time due to planting, bad weather, or gathering documents for taxes and the census. All operations are important and every response matters. NASS is committed to giving producers every opportunity to be represented in these widely-used data.

Federal law mandates that everyone who received the 2017 Census of Agriculture questionnaire complete it and return it even if not currently farming. NASS will follow-up via mailings, phone calls, and farm visits with producers who have not yet responded. To avoid these additional contacts, farmers and ranchers are encouraged to complete their census either online at <u>www.agcounts.usda.gov</u> or by mail as soon as possible. # VitisGen 2 Webinar: Automated Evaluation of Grape Breeding Progeny to Reduce the Phenotyping Bottleneck

*Vitis*Gen2 While genetic information is becoming inexpensive, measuring attributes of interest such as disease resistance or cluster architecture has been a laborious, manual process. VitisGen researchers are developing methods of more rapidly and objectively screening 'mapping populations'. Their goal: to streamline the process of associating plant traits with genetic markers.
