Bud Hardiness Status Heading into 2019

Bud Hardiness Status Heading Into 2019

Before we head off for our holiday break, I thought it would be good to update everyone on where we stand with bud hardiness at this point in the season. Tim Martinson and Bill Wilsey have been tracking bud hardiness in four cultivars — Concord, Noiret, Cabernet Franc and Riesling - from Geneva since early November. At this point, bud hardiness looks to be good for all four varieties (see table).

The question that I'm sure is on many minds, though, is how hardy the vines were on Thanksgiving morning, when temperatures in the Finger Lakes took a bit of a nose dive for about 24 hours. We don't have samples from other Finger Lakes vineyards from that time period, so our initial impressions are only based on our lab results from Geneva.

Looking at the hardiness of the vines at that point in time, LT₅₀ values were below 0°F to various extents (see table). Given these results, it's likely that natives and most hybrids suffered minimal bud loss from this temperature drop. For *vinifera* varieties, the amount of damage will depend on localized conditions around the particular vineyard.

Low temperatures around the region stayed above the LT₅₀ values at that point in time, for the most part, but a few locations got cold enough that there is a decent possibility that less hardy buds suffered some injury. In addition to the cold temperatures, the winds were very calm during the middle of the night, which means that temperatures near the ground or on lower fruiting wires might have been a little lower than those reported by the weather stations.

Based on these results, I would suggest that growers check for bud mortality in their vinifera blocks before starting to prune them this winter. Hopefully, this is the only incident that we need to worry about this winter.

We will start our annual sampling for bud hardiness in the region's vineyards in January. We will let everyone know results when we get them. In the meantime, you can see the most recent results from the Geneva sampling, and the resulting graphs, at the Bud Hardiness project's webpage, https://grapesandwine.cals.cornell.edu/extension/bud-hardiness-data/2018-2019-data/.


Update on the Vineyard Improvement Program for Concord Growers

As announced in the last issue of the Vineyard Update, the State of New York is implementing a Vineyard Improvement Program (VIP) to provide assistance to Concord grape growers who want to convert any of their Concord blocks to a different agricultural crop. Because of the funding source (the Southern Tier Agricultural Industry Enhancement Program), the only Finger Lakes growers that are currently eligible to participate in the program are those in Schuyler and Steuben counties.

When the VIP was announced, eligibility was extended to growers in Erie and Niagara counties, which obviously are not in the Southern Tier, because of their connection to the Lake Erie Regional Grape Program, and that there are potential candidates for the program in those counties. We believe that the program should be extended to Concord growers in other counties as well, and discussions have begun with Ag & Markets to do exactly that.

To help support that position, we would like to know how many growers in the Finger Lakes might be interested in participating in the VIP, and how many acres they would consider enrolling in the program. Indicating your interest **does not** commit you to anything – we would just like to have an idea of the potential interest in the program in the Finger Lakes region. <u>Concord Vineyard</u> <u>Improvement Program</u>



\$1.325 million to Concord Grape Growers for Vineyard Improvements – to remove unwanted Concord vineyards and replant grape varieties or other agricultural crops.

Concord vineyards of an acre or more of land. Active or abandoned. Live and/or dead vines.

Rolling application period. First come first served, until funds are expended. Priority will be given to abandoned vineyards close to vineyards in commercial production.

Applications accepted Oct. 15, 2018 through Oct. 15, 2022.

Each eligible project must not exceed \$50,000

Funding is up to \$1,500 per vineyard acre which includes:

50% of removal cost of Concord grape vines

25% of replanting cost (trellis, plant material, labor) Seed costs are not eligible.

Removal projects should be completed within 12 months of approval. Replant projects should be completed within 36 months of approval.

To be eligible a **business plan** must show an increase in production, enhanced farm profitability and/or increased environmental compatibility of the farm operation or IPM compatibility with neighboring vineyards.

Ag Labor Resources

Hopefully, you have noticed that the Vineyard Update has been including some articles lately from our Ag Workforce Development specialist, Richard Stup. I highly recommend Richard's website, http://agworkforce.cals.cornell.edu/, to anybody who is responsible for managing any kind of labor on a farm in New York State. You can sign up to receive email notification about new postings on the site. He has already developed some excellent resources to keep farm employers up to date on regulations and requirements, and how to comply with them.

One of the most recent ones to come from his program is a webinar designed for farm employers about preventing sexual harassment, including how to comply with New York's new requirements for employee training. Ag Labor Road Show

Another program that Richard is helping to present for farm employers is the Ag Workforce Development Council's *Labor Road Show II.* This program will be presented in several locations around the state beginning next month. The program will include discussion of topics like farm employee housing, new employee onboarding, sexual harassment prevention, wage and hour laws, engaged employees, safety updates, upcoming "worker care" programs, and more. Finally, a quick reminder from Richard about the upcoming adjustment in New York's minimum wage.

Minimum Wage Annual Adjustment

Attention employers, it's time to get ready for the annual increase to the New York minimum wage. The state's minimum wage law passed back in 2016 provides for annual increases that become effective at the end of each year. New York City wages are highest but we don't have many farm employers there. Long Island and Westchester minimum wage goes to \$13.00 on December 31, 2018 and the "remainder of New York" minimum wage increases to \$11.10 on the same date. Make sure you update your payrolls at the end of this month to reflect the change in pay beginning January 1, 2019. Details can be found at New York state's minimum wage website.

Also remember to update your mandatory state minimum wage poster. You can find a copy at the same state website. Right now the old version for 2018 is still up so we need to wait a few more weeks until the new version is posted.

Save the Date for the 2019 Becker Forum on Farm Labor

Farm worker housing, labor law compliance, and the federal guest worker program (H-2A) are key themes for the 2019 Becker Forum. The event will take place on Monday, January 14 at the Holiday Inn in Liverpool, New York. Employer compliance with new sexual harassment prevention laws will also be a prominent topic.

Featured speaker Lynn Jacquez, from the CJ Lake law firm in Washington, DC will address what policy positions to expect from the new Congress and the Administration in the year ahead. She will also address immigration enforcement trends and worksite issues that are important for farm employers.

Three presentations will focus on farm-provided employee housing. Nancy Hagopian from the NYS Department of Health will provide recommendations for improving existing housing. Ed Urbanick from Farm Credit East will discuss financing for construction and renovation of housing. A featured farm employer panel will discuss best practices for managing worker housing.

The forum will also provide information related to the H-2A guest worker program, including how some dairy farms successfully using it to access workers. Current changes in the H-2A program will be reviewed and information will be provided on how to effectively hire foreign-born workers through the program.

Attorney Michael Sciotti from the Barclay Damon Law Firm in Syracuse will inform farm employers about what they must do to comply with New York's new regulations on sexual harassment prevention policies and training.

Northern Grapes Webinar:

Impact of fruit zone sunlight exposure on fruit composition of cold climate hybrid grapes Thursday, January 17, 2019 1:00 PM Eastern

Dr. Amaya Atucha

Assistant Professor and Fruit Crop Extension Specialist, University of Wisconsin Madison, Wisconsin



Dr. Atucha's research program focuses on fruit crop physiology and production of deciduous fruit crops (cranberries and cold climate grapes). The goal of her extension program is to deliver up to date, research-based information to fruit growers that will lead to improve production practices of fruit crops in Wisconsin.

The webinar will present results on the effect of pre-veraison leaf and lateral shoot removal treatments on organic acid and sugar profiles for Brianna, Frontenac, La Crescent, and Marquette in southern Wisconsin. The effects of the treatment on juice and wine total phenolic concentrations (TPC), monomeric anthocyanin concentrations (MAC), and percent polymeric color for Frontenac, Marquette, and Petite Pearl will also be addressed.
