It's that time of year again... TIME TO RENEW YOUR MEMBERSHIP.

You should have received an enrollment card in the mail from the CCE office nearest you. The Chautauqua County enrollment card has proven to be a bit confusing so, if you need some help with filling it out, just give us a call or you can use the **enrollment form we are providing below at the end of this Update**. Please note that the CCE card needs to be mailed to your local CCE office, while this enrollment form can be sent directly to CLEREL in Portland. The address is noted on the form.

You will notice that there is a \$25.00 fee being charged for the receipt of Hard Copy Vineyard Notes Newsletters. This was something that much consideration was given. The other fruit and

vegetable programs had already begun charging this amount for hard copies a few years back, but we wanted to hold off until more of our members were comfortable using the internet and e-mail. Penn State programs are actually moving towards a mail free environment, using <u>only</u> e-mail, texting and other electronic measures for information dissemination. We are following the lead of our local grape processors, Penn State, and the majority of other regional fruit and vegetable programs in going paperless. All correspondence from LERGP will be in electronic form. If you feel you must have a hard copy of newsletters, that option is available for a \$25.00 fee.

There is a benefit to opting for e-mail delivery of the Vineyard Notes. You will see it in color making the charts, maps and photos that are included in articles much easier to understand and pull details from. 

#### Fertilizer Prices

While some fertilizer purchases may already have been made, growers are likely to continue timing purchases and deliveries throughout the winter months. While there is risk involved in trying to time the fertilizer market, there is more risk in ignoring the markets and buying these commodities on demand.

#### Nitrogen

Urea prices continue to fall, though retail prices across major markets vary widely. Price at the Gulf has fallen to \$413. That should place retail prices below \$600. Despite that, averages in Iowa remain at \$615, with an upper threshold of \$680. While these prices have been falling the last few months, retail prices remain above prices paid by farmers in 2011 and 2010. It appears that the average farmer, paying 554 and 526 per ton for those years respectively, has timed purchases rather well.



#### **Potash**

Potash prices have continued to fall from their extreme highs of \$900 per ton. After a stable period last year, prices fell from a \$470 range to a \$400. \$400 has established itself as a floor for the market. As a hedge against rising prices a maintenance-sized application might be appropriate. While some growers might not find the application entirely necessary, based on last year's crop, it could prove to be an important hedge against higher prices. If you do not have a crop loan or a line of credit to pay down, with interest rates extremely low, the soil might not be a bad place to bury

a little bit of money (so to speak). Again given the low crop size, most growers won't have an opportunity to justify a 100-200 lb. application but a smaller maintenance application in the range of 50 lbs. could pay dividends. With fertilizer prices falling, retail prices tend to vary widely. This wouldn't be something I would consider if prices were above \$450 per ton retail.

#### Lime

Not much to say here. Like always, lime is extremely inexpensive. Trucking lime typically costs at least twice as much as the lime itself. Growers cannot afford to mismanage lime applications. Too much or too little decreases the efficiency of the aforementioned and relatively extremely expensive soil nutrients.

#### NOTES FOR PEOPLE TAKING EXAMS

NYS-DEC has raised exam fees to \$100.00 for all exams. This fee must be paid prior to the exam date. If you are planning on taking any exam, contact the Buffalo DEC office at 716-851-7220 at least two weeks prior to the exam session. You will then be sent an exam application form and test instructions by the DEC.

Cornell Cooperative Extension can provide you with the books for the exams (see attached order form). However, questions about eligibility to take the exams or current certification status must be handled by the DEC office in Buffalo.

## Notes for Buying Manuals for the Exam

**Commercial Applicators**: You will need the "Core Manual" and the category manual for the area in which you will be certifying.

**Private Applicators:** You will need to get the "Core Manual" plus the private category manual for the area in which you will be certifying.
