Grapevine Bud Hardiness Update

After a warmer than normal December, the first part of January has felt a little closer to what most of us are used to at this time of year, especially the last few days. I had a few questions about how the warm temperatures earlier in the winter were impacting vine hardiness, and here's the basic answer:

It may have had a slight impact, but not enough to cause any concern about bud damage at this point.

The table below shows the results from the first couple of sample collections that we did in the Finger Lakes during December (12/6 and 12/20). Even with the warm weather that month, the LT_{50} values were still about where we would expect them to be at that time of year, and all below 0°F. Since then, the colder temperatures this month have pushed those LT_{50} values even lower, meaning the buds are able to withstand colder temperatures before we start to see significant damage. And just for a little more context, I also included the LT50 values from this same time of season last year (also collected in Geneva), and if nothing else, a few of the cultivars may actually be somewhat hardier now than they were a year ago.
